 - May need to hire a company to host/create
 - Terry will do research and get estimates
 - o Terry will work with Mary and Rev Mark
- Search Committee Timeline (10) Rev Mark/Dorothy
 - o Current timeline is to have a settled minister in the pulpit in Summer 2022
 - o In order to do that, would need to have a search committee in place January 2021
 - Other option is to extend Rev Mark's contract to 3 years, which would mean a settled minister in the pulpit in Summer 2023
 - o Concerns about waiting on the search
 - O How are other churches doing a search during the pandemic
 - UUA have been working with congregations and training
 - Last year around 100 interim ministers available for 125 openings
 - Dorothy will call UUA to ask
- PPP Forgiveness/EIDL Update (5 minutes) Donna
 - o All information is in hand
 - Will be completed either this week or early next week
- Racial Justice and CRT (Critical Race Theory) (15) Rev Mark/Dorothy/All
 - o UUA has been working on Racial Justice significantly the last several years
 - o UUA potential 8th principal
 - o Critical Race Theory racism is a part of every part of life
 - We have lost members who feel that we have gone too far
 - o Sherry will do classes about this to help educate the congregation
