Moving forward would require conversations with the UUA transitions office. Betty expressed that there had been impatience to get a settled minister, so care would need to be taken to present the idea to the congregation.

 Status We don't currently have a stewardship chair. In a tangent discussion about Leadership development, it was agreed that we need stronger "succession planning."
- Board Goal Create a Welcoming Culture: Mike would like to work with the
 congregation to address the questions, "What does it mean to be welcoming?" and
 "Whom do we want to welcome?" Mike posed two questions for the board to
 ponder: Do we want to take this on? If so, how much time and effort do we want to
 put into it? Betty pointed out that the inclusion group is currently addressing this
 issue but acknowledged that the message should reach a wider audience.
