Business

Emeritus membership for Connie Rayes

(Article IV, Section 1, Paragraph C of the Bylaws: "Emeritus members are persons who have been long-time members and who for reasons determined by the Board of Trustees are offered life-time honorary membership without the requirement of providing annual financial support.")

Mke moved that Connie Reyes be granted emeritus member status. Ruth seconded; The motion passed.



Update on Start Up for Dr. XK and Tim: Dr. XK conveyed that Southern region staff member Cameron Young doesn't want to combine minister and DLRE. Dates have yet to be set. The minister's startup will probably be next year, maybe January

Update on dismantling oppression in coffee hour: Weekly coffee hours won't be possible while Fellowship Hall construction is underway. Dr. XK called some men so that coffee hour will not be handled exclusively by women.

Reserve account discussion

- a) Accounts with problematic money transfers / Accounts no longer being used. Loan with Frost Bank was approved. Frost discovered a lien on our property. There may be notes from previous minutes saying that the related loans had been discharged. Donna and Polly will investigate
- b) Reserve fund to float "loan" for parking lot request from Membership? We can spend the money, charging it to membership; pending approval of Dr. XK, membership will do a fund lunch to replenish their funds.

Healthy relations proposal: Dr.,XK read it and made comments. We will discuss it at the next meeting.

December board meeting: we will meet at church for a social time as well as touching base on necessary business

Fundraiser to generate the \$5,000 for "other fundraising" included in the 24-25 budget: Polly will investigate whether donated art work is still at the church and what the potential value might be.

Stewardship Update: The January listening session will take the form of a "finance 101 session. Board representatives will discuss how the budget is made, answer questions about items, and invite input about priorities. The stewardship asked for and received support from the board for a leadership event in late February for premiere donors and leaders. They also requested and received informal promises of help with small groups (cottage meetings) in early March.

Finance committee: Donna would like to recruit three people who have finance experience, and would like board members to give her recommendations. She will write up a job description.

Ministerial search timeline, getting started: Betty raised the question of whether it had been formally and finally decided that we would seek a settled minister as opposed



to a contract minister. Carol will consult with the congregational transitions director as to their current best advice. Betty will look for a doc created by Heather Hedquist that outlined the differences. The congregation needs to be informed about differences between contract and settled ministers, and their input solicited. This will be the main topic of the December board listening session.
