# • Motion: Employer Participation Agreement

o Motion: Whereas the First Unitarian Universalist Church is committed to assisting its employees prepare for their retirement years, and Whereas the Unitarian Universalist Organizations Retirement Plan As Amended and Restated Effective January 1, 2025, including all subsequent amendments (the "Plan") is the retirement plan sponsored by the Unitarian Universalist Association, therefore Be It Resolved that the First Unitarian Universalist Church of San Antonio hereby amends their Employer Participation Agreement dated with the Plan to change the following Elections: We affirm that our existing Agreement on file with the UUA (Plan Sponsor) binds us to complying with all the provisions of the Plan and the elections made by our congregation in our existing Employer Participation Agreement until such time as we complete and submit a new Employer Participation Agreement to the UUA Retirement Plan Committee, and they acknowledge receipt and approval of an authorized implementation date.

Donna moved, Polly seconded. Motion passed unanimously.

- **Update regarding renovation/demolition:** The board is invited to a meeting with builders on Tuesday, Feb. 25, 3 pm. Renovations will start March 3.
- Settled Minister Search Committee member input update: Board members are requested to let Polly know their availability for dates to host cottage meetings, where suggestions will be solicited.
- **Bylaws review** Mike said that mostly only simple corrections which are not timesensitive are needed. We also need to discuss changing term limits for some board positions. Mike will write up suggested changes and we will discuss term limit changes at the March meeting.
- **Budget** Donna reviewed proposed 2025-26 budget. Highlights: An unexpected payment of \$38K from the government will help pay for ministerial search and the DLRE's immigration legal fees. A ¼ time facilities manager position is proposed. The proposed job description is forthcoming. Congregational Administrator pay needs to be brought in line with UUA guidelines. The overall request will be for 9% above last year's budget. Polly got feedback on the stewardship brochure.
- Walmart "Spark Good" program non-profits can appear on a list and shoppers can "round up" their bill for the charity of their choice Tabled
- Request by Nasim Memon for review of Social Justice Committee Ruth presented general concerns. Dr. XK said that the committee engages in continual informal self-reflection. The general consensus among BIPOC participants on the social justice committee is that the committee is generally self aware and that they continually strive to reflect UU values.
- Land Acknowledgement performative vs. actual connection with native peoples? Tabled.
